1999-2004 Methodist Presbyter South Holland Circuit, S Lincs & Leicester (Trinity) Circuit. My central vocation remains the ministry of Word, Sacrament and Pastoral Oversight. In the first five years of ministry, I pastored Methodist and ecumenical congregations, served as a District Youth Officer, and as Methodist Chaplain to the University of Leicester. I worked with the Diocese of Leicester in teaching Exploring Christian Life and Faith, and as a member of the Bishop's Interfaith Forum.

2004-2008 Co-ordinating Chaplain City, University of London & University of East London Building on my experience in Leicester, I took on the role of Co-ordinating Chaplain at two universities in London in 2004. This involved building and leading two multi-faith teams and re-establishing services where they had ceased or been reduced. I attended Student Services meetings as a Head of Service and worked with colleagues on issues around suicide, sudden death and global disasters, as well as being one of the leads for the emerging Prevent Strategy at the time. I also served on the University Research Ethics Committee.

2008-2012 Lecturer (Grade 7) in Religion & Social Ethics City, University of London
I worked within the School of Community & Heath Studies, training healthcare professionals in faith
awareness and cultural diversity, public health ethics and mentorship for learning in practice. I was the
School's lead for Personal Tutoring and chaired a number of Fitness to Practice panels.

2012-17 Director, Global Christianity Programme Queen's Foundation, Birmingham This was a leadership role that involved creating a new programme and recruiting staff, designing MA modules (and a period as MA Programme Leader) and developing a parallel programme of intercultural learning, contextual theological reflection and support for those engaging in British Higher Education from the Global South. It also involved engagement with Heads of Partner Churches and potential external funding and scholarship bodies. I was also responsible for developing the MEET (Mutual Encounter & Exchange for Transformation) Programme for home students in ministerial formation, preparing and leading them in overseas mission trips and placements.

During this time, I was elected as President of the Methodist-related Theological Schools in Europe (MTSE), working with a Europe-wide Coordinating Group to build the association, including organising two international gatherings: an academic & student Conference on reconciliation and a Seminar on the Church in Europe.

2017-2022 Partnerships & Research Officer Southlands College, University of Roehampton A mainly external-facing role, assisting the Head of College to engage with the wider Methodist community in Britain and Ireland, and with IAMSCU (International Association of Methodist-related Schools, Colleges and Universities).
